Arguing that explanatory uniqueness warrants inference, and exposing flaws in contending philosophical positions that sever explanatory power from epistemic justification, Leplin holds that abductive, or explanatory, inference is as fundamental as enumerative or eliminative inference, and contends that neither induction nor abduction can proceed without the other on pain of generating paradoxes. Leplin's conception of novelty has two basic components: an independence condition, ensuring that a result novel for a theory have no essential role, even indirectly, in the theory's provenance; and a uniqueness condition, ensuring that no competing theory provides a basis for predicting the same result. Showing that alternative approaches to novelty fall short in both respects, Leplin proceeds to a series of test cases, engaging prominent scientific theories from nineteenth-century accounts of light to modern cosmology in an effort to demonstrate the

epistemological superiority of his view. Ambitious and tightly argued, *A Novel Defense of Scientific Realism* advances new positions on major topics in philosophy of science and offers a version of realism as original as it is compelling, making it essential reading for philosophers of science, epistemologists, and scholars in science studies.

*The Divine Lawmaker* - John Foster 2004-01-15

John Foster presents a clear and powerful discussion of a range of topics relating to our understanding of the universe: induction, laws of nature, and the existence of God. Physicalism, or Something Near Enough -  
Jaegwon Kim 2007-12-03

Contemporary discussions in philosophy of mind have largely been shaped by physicalism, the doctrine that all phenomena are ultimately physical. Here, Jaegwon Kim presents the most comprehensive and systematic presentation yet of his influential ideas on the mind-body problem. He seeks to determine, after half a century of debate: What kind of (or "how much") physicalism can we lay claim to? He begins by laying out mental causation and consciousness

as the two principal challenges to contemporary physicalism. How can minds exercise their causal powers in a physical world? Is a physicalist account of consciousness possible? The book's starting point is the "supervenience" argument (sometimes called the "exclusion" argument), which Kim reformulates in an extended defense. This argument shows that the contemporary physicalist faces a stark choice between reductionism (the idea that mental phenomena are physically reducible) and epiphenomenalism (the view that mental phenomena are causally impotent). Along the way, Kim presents a novel argument showing that Cartesian substance dualism offers no help with mental causation. Mind-body reduction, therefore, is required to save mental causation. But are minds physically reducible? Kim argues that all but one type of mental phenomena are reducible, including intentional mental phenomena, such as beliefs and desires. The apparent exceptions are the intrinsic, felt

qualities of conscious experiences ("qualia"). Kim argues, however, that certain relational properties of qualia, in particular their similarities and differences, are behaviorally manifest and hence in principle reducible, and that it is these relational properties of qualia that are central to their cognitive roles. The causal efficacy of qualia, therefore, is not entirely lost. According to Kim, then, while physicalism is not the whole truth, it is the truth near enough.

Brian Leiter defends a set of radical ideas from Nietzsche: there is no objectively true morality, there is no free will, no one is ever morally responsible, and our conscious thoughts and reasoning play almost no significant role in our actions and how our lives unfold. He presents a new interpretation of main themes of Nietzsche's

moral psychology, including his anti-realism about value (including epistemic value), his account of moral judgment and its relationship to the emotions, his conception of the will and agency, his scepticism about free will and moral responsibility, his epiphenomenalism about certain kinds of conscious mental states, and his views about the heritability of psychological traits. In combining exegesis with argument, Leiter engages the views of philosophers like Harry Frankfurt, T. M. Scanlon, and Gary

Watson, and psychologists including Daniel Wegner, Benjamin Libet, and Stanley Milgram. Nietzsche emerges not simply as a museum piece from the history of ideas, but as a philosopher and psychologist who exceeds David Hume for insight into human nature and the human mind, repeatedly anticipates later developments in empirical psychology, and continues to offer sophisticated and unsettling challenges to much conventional wisdom in both philosophy and psychology.
